As winter began to lessen and turn into the spring of 2020, UMC of El Paso, all area hospitals, citizens, patients, our El Paso community, and the entire nation would find itself in the midst of a pandemic never experienced by our generations. FEBRUARY 26

Governor Greg Abbott provides Texas with an update on the virus.

MARCH II

New entry and screening procedures are now in place for all UMC Associates, EPCH Associates, Texas Tech physicians and staff, vendors, visitors and partners. Visitors will be given a colored wrist band that is changed daily. Lobby entrance will only be used for visitors or vendors.

MARCH 16

UMC installs four (4) screening tents in order to protect the safety of patients, visitors and staff. They will be used to quickly screen visitors for signs and symptoms of the virus while simultaneously helping to process visitors to the hospital.



MARCH 23

UMC, El Paso Children's Hospital, Hospitals of Providence and Las Palmas Del Sol Heathcare implement a no-visitor policy. The City of El Paso Department of Public Health shares a step-by-step process on how the public can be tested for COVID-19. Residents are asked to stay at home and to contact a health provider for flu-like symptoms. Testing begins when all sources of illness have been ruled out. Evidence of community spread is acknowledged as 40 COVID-19 cases are reported in the city. Residents are reminded to run errands alone, cover coughs, avoid touching the face, practice regular hand washing and clean areas with disinfectant. MARCH

Governor Greg Abbott declares COVID-19 is a statewide public health disaster and instigates:

- I) a prohibition of gatherings larger than IO,
- 2) closing of bars and gyms,
- 3) restaurants to switch to takeout or delivery,
- 4) closing of schools, and,
- 5) prohibition of visitors at nursing homes.

MARCH 13

El Paso health officials report the first person in El Paso infected with COVID-19.

MARCH 17

Only one "essential" visitor is allowed to visit a patient.



MARCH 24

Jacob Cintron, CEO & President of UMC, and Cindy Stout, CEO & President of El Paso Children's Hospital, issue a message to staff of both hospitals that patients and staff are their number one goal in safety and well-being.

MARCH 29

COVID-19 cases reach 40 in El Paso. The Health Authority begins to work with the City and County to prepare stricter orders.

APRIL 10

Governor Greg Abbott signs an executive order on how Texas businesses will begin to open. On April 17th, he restarts the economy, loosening some restrictions. Phase Two for reopening daycares, bars, recreational businesses and sports is outlined on April 18th. There are 645 positive cases reported in El Paso.

APRIL 27

Governor Abbott lets restaurants, movie theaters and malls open with limited capacity.

MAY 20

Bravo Cadillac donates \$10,000 to fund a digital monitor at UMC so Associates can receive COVID-19 updates.

JUNE 16

UMC opens Antibodies testing
to all Associates. As the
world has seen since the
beginning of the COVID-19
pandemic, the importance of
testing is of the utmost priority.
Time slots for the antibody
testing are completely filled for
the first week with over a
hundred Associates being
tested in the first day.

JULY 6

El Paso leaders extend its disaster declaration and emergency ordinance. The order is extended for another 30 days following the announcement of an increase in COVID-19 cases in El Paso.

APRIL 23

Marathon Petroleum donates 9,600 N95 respirator masks to UMC.



MAY

UMC, El Paso Children's Hospital, Texas Tech Physicians of El Paso urge individuals who have fully recovered from COVID-19 to donate convalescent plasma as a key weapon in the fight against the virus. Vitalant, the nation's largest independent blood provider, launches a program to treat COVID-19 patients with blood plasma donated by people who have recovered from the disease.

JUNE 2

Matthew and Camila McConaughey team up with Lincoln to deliver 25,000 simple surgical masks for UMC.



JULY I

- UMC Opens 'Clean Cube' for COVID-19 Screening.
- University Medical Center of El Paso announces another first-in-Texas, first-in U.S. advancement in healthcare for the El Paso community with its Synergy Medical Solutions Rapid Response Clean Cube, made possible by Woodmore Health Group. Clean Cube is dedicated to COVID-19 screening, located behind UMCYsleta located at 300 S. Zaragoza.

12,501 positive cases in El Paso.

AUGUST 26

Dr. Joel Hendryx, Chief Medical Officer at UMC, urges plasma donations after Food and Drug Administration (FDA) authorizes emergency use.

SEPTEMBER 3

Mayor Dee Margo, County Judge Ricardo Samaniego and Dr. Hector Ocaranza all stress to the community not to gather over the Labor Day weekend.

OCTOBER 21

UMC is featured on ABC World News Tonight with David Muir, ABC News Prime and Good Morning America discussing the current surge of patients with COVID-19 in El Paso.



OCTOBER 25

UMC and El Paso Children's Hospital partner to provide additional space for non-COVID-19 Adult Patient Care.

NOVEMBER 2

There are 51,536 positive cases in El Paso with 605 deaths.

DECEMBER 15

UMC becomes the first hospital in the region to receive the Pfizer COVID-19 Vaccine. Crystal Molina, Charge Nurse in the Emergency Department is the first El Pasoan to receive the vaccine followed by four other UMC Associates. UMC receives 2,925 vaccine doses which are prioritized to frontline healthcare heroes caring for COVID-19 patients.



AUGUST 13

Media for the Committee of 100 donate 8,000 N95 masks to UMC frontline workers.

AUGUST 31

There are 20,460 positive cases in El Paso with 419 deaths.

OCTOBER 15

City and county leaders in El Paso announce they will increase restrictions for restaurants and some businesses.

OCTOBER 24

Hospitals throughout El Paso, including UMC, work together with BorderRAC (Border Regional Advisory Council) to take proactive steps to provide a continuum of care for El Paso patients in need of ICU care. These patients are airlifted to other healthcare facilities in Texas.

OCTOBER 30

El Paso County Judge Ricardo Samaniego orders two-week shutdown in El Paso due to COVID-19 spike.

NOVEMBER AND DECEMBER

City officials ask El Pasoans not to gather for Thanksgiving. El Paso leaders say families going to the store in big groups to shop is one of the leading causes of the virus spreading rapidly through El Paso.

NEIGHBORHOOD HEALTH CENTERS

Dr. Rhonda Fleming, NHC Infectious Disease Provider, has provided continued up to date COVID-19 guidelines and trainings for our providers and staff throughout the pandemic.

As a specialty physician, Dr. Rhonda Fleming's focus is on infectious diseases. She has been with UMC's Neighborhood Health Centers since January of 2019, previous to that served as faculty at Texas Tech University Health Sciences Center in El Paso. As an infectious disease provider,

Dr. Fleming has continued to give up-to-date COVID guidelines and trainings for providers and staff throughout the pandemic.

She publishes updates every six weeks to all the clinics and the community on a web platform. When asked about the accomplishments of the Neighborhood Health Centers, Dr. Fleming replied, "I think it is a combination with the task force and Leonor Chavez, Assistant Administrative Clinic Services. They work together to make sure things are communicated to the managers of the clinics. They make things happen. Along the years, these clinics have grown. I have been witnessing how they have been growing."

In response to COVID-19 in our community, NHC quickly expanded services with the use of tent set-ups at various clinic sites and the Clean Cube at the Ysleta site. The Clinic P.I. Team, Occupational Health and Laboratory created an associate and patient assessment, collection and testing processes to facilitate testing of our associates and patients which complied with all CDC guidelines.

Expansion of healthcare services which included multiple specialty improved patient access, continuity and quality of care provided to patients. The rapid deployment of Telehealth and Telemedicine services allowed the clinics to adapt to the citywide shut down and continue to provide healthcare to our community.





NHC continues to meet the UMC mission via expanding the Specialty Services to meet the growing demand of our community needs and the continued collaboration with our community partners such as the El Paso County, El Paso Fire Department, Housing Authority, UTEP, and pharmaceutical companies to provide quality of services.



NEIGHBORHOOD HEALTH CENTERS (NHC) TIMELINES

NHC COVID-19 PANDEMIC INITIATIVES IMPLEMENTED:

- Led the endeavor in the city with the implementation of Telehealth and Telemedicine
 expansion of primary care and specialty services in April, ten (10) days after the citywide
 shutdown due to COVID-19. Telemedicine visits totaled 30,858 conducted from April to
 September 2020. The rapid deployment of Telehealth and Telemedicine services allowed
 the clinics to adapt to the citywide shutdown and to continue to provide healthcare for the
 community.
- Expanded services with the use of tent set-ups at various clinic sites. Opened Clean Cube at
 the Ysleta Clinic for COVID-19 screenings in June 2020. Implemented multiple COVID-19
 pandemic response initiatives such as telephone registration, a screening process for entry to
 clinic sites with a computerized thermometer and placed Plexiglas in multiple Associate
 work areas. Handled a record number of calls in the Neighborhood Health Centers'
 scheduling department of 478,566 calls.
- Community Collaborative Partnership Projects to increase access to healthcare such as UTEP, El Paso Children's Hospital's Collaboration for COVID-19 Testing, Rural Mobile Unit, Housing Authority Clinics and the County of El Paso.
- Created an associate and patient assessment and began a collection and testing process
 to facilitate testing of associates and patients which complied with the Centers for Disease
 Control and Prevention (CDC).

NHC FY 2020 INITIATIVES:

- Added a transitional clinic for hospital discharges. Initiated transitional clinics in October 2019 at the Far East on George Dieter with Dr. Jose Silva and Far West in April 2020 with Dr. Wayne Watson.
- Hired OB/GYN physicians, a neurosurgeon and a general surgeon.
- Expansion of G.I. specialty with Dr. Carmela Morales and Dr. Ruben Ramirez in October 2019.
- Added General Surgery to Far East and West locations with Dr. Michael Lara in January 2020.
- Expansion of Pediatric Services at Far East in July 2020. The
 Pediatric Initiative began with the recruitment of a medical doctor in September 2020.
- Expansion of OB/GYN services at East, Ysleta and West in August 2020 with Dr. Daniela Pino, Dr. Antonio Romo and Dr. Mario Nutis. Recruited Dr. Diego Ramirez in March 2020.
- Expansion of Acute Care Services at Far East in August 2020.
- Expansion of Neurosurgery Services at Far West with Dr. Akshay Gupte in August 2020. East and Fabens in September 2020 with Dr. Chin Sing (David) Wang and Dr. Luis Vasquez.





- Fabens Rural Health Clinic received a successful Rural Health Certification. Established an Integrated Preparedness Plan with the community of Fabens and received recognition from HHS auditors for "Best Practice" Implementation.
- Celebrated its first year anniversary as the El Paso County Jail Healthcare Provider.
- Conversion of a new EMR System successfully reduced EBEW edits from 8.7 million to 416,730.
- Successful BBRN reviews with identified "Best Practices" from consultant in telemedicine process and documentation.
- Initiated an ET3 Task Force with the El Paso Fire Department and UMC/NHC.
- Continued collaboration with the Housing Authority for multiple Housing clinics.
- Collaborated with Pfizer for the Pneumococcal Pediatric Initiative to educate families and vaccinate children.
- Continued to meet UMC's mission via expanding the Specialty Services to meet the growing demand of community needs and the continued collaboration with community partners such as the El Paso County, El Paso Fire Department, Housing Authority, UTEP and pharmaceutical companies to provide quality of services.

The pandemic has occupied much of this department's time since March 2020. Infection Prevention and Control has been involved in every aspect of the COVID-19 response, including employee education on the use of personal protective equipment (PPE), CDC guidelines regarding the process of the COVID-19 virus, education on testing, quarantining or self-monitoring at home, and exposure investigation. Whatever valuable information, education, and assistance this team has provided has helped to alleviate fear, mistrust, and miscommunication. The team has led the response in protection from the virus and prevention in spreading the virus – to include visits to UMC clinics and in setting up the flow for patient visits at the clinics. They were involved in the Surge process from the beginning, working with UMC's Engineering and Environmental Services (EVS) to help create safe, clean COVID-19 units. The department worked with a multi-disciplinary team to write a COVID-19 Plan, which continues to be a fluid document as conditions change rapidly. They have been on call 24/7 to talk with anyone with questions or concerns regarding the multiple aspects of a pandemic. They assisted in developing the protocol for reuse of N-95 masks via sterilization. They have met challenges every day in the face of peaks in the number of cases. They are in daily communication with our local health department and provide mandatory data daily to the State regarding COVID-19 numbers at UMC.

LABORATORY: MICROBIOLOGY DEPARTMENT

As the cold of February 2020 lingered, the Microbiology Department of UMC installed MALDI Biotyper, a Becton Dickinson (BD) Instrumentation for Infectious organism identification and susceptibility. Later, three COVID-19 testing instruments would be installed by June of 2020.

MALDI Biotyper allows the identification of infectious organisms within minutes from bacterial growth. This facilitates a rapid response for specific target antibiotic treatment. It also decreases hospital stay for the patient and cuts the cost for both the hospital and patient.

COVID-19 testing is now done in-house and has decreased the turnaround time for results from four to five days to the same day. Patients can now be admitted to the proper hospital floor knowing their COVID-19 status and within a few hours of specimen collection are appropriately able to be treated.



SUPPORT SERVICES

INFORMATION TECHNOLOGY

Information Technology (IT) and its UMC and El Paso Children's Hospital IT Management Team have not been idle.

From implementing more than 100 new projects in 2020, IT managed the COVID-19 crisis in these ways:

- A set up of more than 200 additional beds to deliver proper patient care and billing.
- Added multiple tents and nursing units complete with computers, laptops, tablets, Virtual Local Area Network (VLAN), Wi-Fi, fiber, cabling, switches, printers, medical device interfaces and more.
- Added 814 new staff and physicians to computer systems for better access to each respective system necessary for their duties.
- Quickly implemented Telemedicine.
- Set up more than 200 iPads on stands for use by patients to communicate with families as well as for physician-to-nurse or physician-to-physician video conferencing.
- Set up more than 400 UMC Associates to work from home.
- Configured and set up Endoscopy to be operational at our micro hospital to handle possible overflow from the hospital.
- Set up freestanding Firstnet Shell (ED system) to properly handle inpatient type setting for patients who needed to stay longer.
- Set up new disaster nurse charting to reduce charting times to accommodate influx of new staff and overflow of COVID-19 patients. Still in process.
- Handled more than a 30 percent jump in increased workload of the Help Desk tickets due to an increase in staff, more patient rooms, patients and devices.

LABORATORY: BLOOD BANK DEPARTMENT

"University Medical Center of El Paso, as the Regional Level I Trauma Center for Far West Texas and Southern New Mexico, has implemented a whole blood program for severely injured patients with life threatening hemorrhage. Whole blood, as opposed to component therapy that traditionally has been used in most trauma centers, provides the essential components to obtain hemostasis and provide oxygen delivery in a more physiologic fashion. The use of whole blood in the battlefields of Iraq and Afghanistan was found to be superior to component therapy (i.e. packed red blood cells, platelets, and fresh frozen plasma) in saving the lives of our soldiers. Whole blood, being used in an increasing number of civilian trauma centers, has demonstrated efficacy in reducing death due to hemorrhage. As part of its mission as a Level I Trauma Center, UMC is proud to have this life-saving therapy available to our patients."

Whole Blood and COVID-Convalescent Plasma is being brought into the hospital for the benefit of UMC patients and their overall recovery. In June of 2020, whole blood was introduced and has been in use since COVID-19 Convalescent Plasma was first approved in April of 2020 for emergency use by the Federal Drug Administration (FDA). Whole blood is indicated for large volume hemorrhaging such as seen with major trauma requiring massive transfusion and rapid correction of anemia, coagulopathy, acidosis and hypothermia. COVID-19 Convalescent Plasma is donated by individuals who experienced COVID-19 and have recovered. Now their antibodies will help aid newly infected individuals to help them recover faster.

UMC, along with other local hospitals, has been working with Vitalant, the nation's largest independent blood provider, to heal patients with Convalescent Plasma. Those who meet that criteria and want to donate plasma are encouraged to apply through the Vitalant website Vitalant.org/covidfree.





HIGHLIGHTS FOR 2020 INCLUDE:

GROWTH OF C.A.R.E.S. CLINIC

In an effort to better serve the children of El Paso, Texas, and surrounding areas, the C.A.R.E.S. Clinic expanded to a new offsite location to provide a one-stop center to evaluate, treat and support victims of child abuse and neglect. Generous grants and donations received by the EPCH Foundation have allowed the Clinic's expansion to better serve the needs of the community in a larger space equipped with amenities that meet the highest standards for care. The C.A.R.E.S. Clinic has been in existence since 2012 through funding from the Texas Medical Child Abuse Resources and Education System (MEDCARES). The Clinic's treatment and services are developmentally, linguistically, and culturally appropriate; designed with a child's needs, abilities and best interests in mind, and intended to reduce the traumatic effects of child abuse and neglect.


In 2018, Texas Child Protective Services (CPS) reported 1,943 confirmed cases and 6,383 allegations of child abuse in El Paso County. In 2017, 172 children died from child abuse/ neglect in the state of Texas, seven of which were from El Paso County. More children die from abuse in Texas than in any other State. This is a significant number for the El Paso community.

The C.A.R.E.S. Clinic collaborates with CPS, law enforcement, and local child abuse/ advocacy stakeholders to provide comprehensive services to children who have been hurt physically and emotionally. This collaborative reduces the number of traumatic interventions for the child to help them and their family heal.

The C.A.R.E.S. Clinic services include:

- Comprehensive forensic medical evaluation and treatment of suspected child abuse, neglect and sexual assault in children under 18.
- Follow-up forensic medical examination and treatment for child victims of acute and chronic sexual and physical abuse.
- "3 in 30" Initiative, medical evaluation for children placed in foster care.
- Pediatric Sexual Assault Nurse Examiner (SANE) services.
- Forensic examination with photo documentation.
- Testing for Sexually Transmitted Diseases (STDs) to include HIV.
- Social services and crisis intervention.
- Processing of application for crime victims compensation.
- CPS case reviews.
- Law enforcement case reviews.
- Court testimony.
- Period of Purple Crying training.
- Referrals for long-term counseling and any other medical services for child victims.

NEUROSURGERY SUCCESS STORY



When a child has a neurosurgical problem, the associated challenges can affect quality of life for the child and the entire family.

To support affected families, the hospital brought in Dr. David limenez in 2019 to provide the community with convenient medical and surgical care to support an active life. We provide surgical treatment for diseases affecting the brain, spinal cord and nerves in infants, children and teens. We actively support our mission to provide the safest and highest quality care by implementing the use of advanced technology. Our patients benefit by undergoing safer, less invasive procedures, and experience less time under general anesthesia. Cutting-edge technology, coupled with our specialized skill and training, ensures children receive exceptional neurosurgical care.

Year after year, we have been able to increase the total number of neurosurgical cases by 100%. This means that fewer patients are having to leave El Paso and are able to receive world-renowned treatment here in the comfort of their home.

HERE WE GROW

In the fall of 2018, El Paso Children's Hospital officially opened the El Paso Children's Hospital Physician Specialists Clinic. This new space was built to support a truly unique, integrative model of physician specialists in one setting.

To date, we have able to provide additional physician specialists including our Cranial and Facial experts, Neurosurgeon, General Surgery experts and finally we were able to add Pediatric Cardiology experts. Our Physician Specialists Clinic continues to enhance the access to critical pediatric specialists in our region.

EQUIPMENT ADVANCEMENT: OVER \$4 MILLION INVESTED

Over the past year, El Paso Children's Hospital (EPCH) was able to invest four million dollars in new equipment. The time is now to continue expanding complex pediatric care in West Texas. Our care must continue to meet the needs of our pediatric region. Some of the equipment that we were able to purchase include:

- Additional equipment and instruments, that allow us to accommodate complex neurosurgical cases and keep patients in El Paso.
- A new Orthoscan, which is a mini C-arm (imaging machine) that allows the surgeon to see bones in real time with the device emitting less radiation compared to the large C-arm machines.
- New instruments and a navigation system for our Ear Nose and Throat (ENT) surgeons. This equipment allows the ENT surgeons to perform complex sinus surgery at EPCH. This is some of the best equipment available to our pediatric ENT surgeons in the area.
- New cameras and laparoscopic instruments for the General surgeons. We now use 4K technology in some of the operating rooms to provide high definition that gives them a better picture during laparoscopic surgery.
- Oral and Maxillofacial surgeons (OMFS) are now using a Brumaba operating room table, which allows the surgeons to sit closer to the patients while operating. OMFS surgeons can now do more minimally invasive surgery using the navigation system which allows the patients to return to normal activities sooner.
- Endoscopy has additional sterilization equipment. We also have additional scopes that vary in size to allow the pulmonologists to work on very tiny or adult-sized patients.
- New urology instruments to support Urologists in complex cases.

This equipment investment allows us to continue to provide the most advanced care to our pediatric population.

ACCREDITATIONS/SERVICE LINE HIGHLIGHTS

RADIOLOGY

- Successful re-accreditation with the American College of Radiology (ACR) for Nuclear Medicine.
- Implementation of Advanced Cardiac MRI Imaging the only specialized pediatric radiologists, in the region.
- Implementation of Advanced MRI imaging; urography, enterography, lymphangiography and defecography only available at EPCH within a 350 mile radius.
- Implementation of Advanced MRI Neuroimaging including tractography, perfusion, and neuronavigation which allows live operative guidance for neurosurgeons performing brain surgery.
- Additional new high tech equipment: MAC Vue EKG (2), Echocardiograms Vivid E10 (2), Ultrasound Logic E10 with elastrograph.

COMMUNITY INVOLVEMENT

EPCH strives to improve the lives and outcomes for children and families needing healthcare and treatment. To accomplish this, EPCH collaborates with several non-profit agencies, local community groups, and children's charities each year. Our relationship with these entities is an important part of improving health outcomes for children across our region by supporting education, advocacy, and promotion of partner events and initiatives.



In 2020 alone, EPCH provided close to \$25,000 in sponsorships and countless hours of community service by hospital staff bringing awareness to a multitude of health topics affecting children in the region. Some of these events were held virtually due to the pandemic.

In 2020 EPCH supported the Ronald McDonald House, community health fairs, March of Dimes, YMCA, Walk a Mile

in Her Shoes YWCA, Candlelighters of El Paso, Royal Run for Hope, KCOS Physician Show, El Paso Diabetes Association, and Lee & Beulah Moor Children's Home.

In addition, we have continued to develop virtual events to stay connected with our families and community. This year we held our fourth annual St. Baldrick's head shaving virtual event to bring awareness to childhood cancer. We also hosted our virtual NICU event.

OUR HEART HEROES

2020 has been a year that has tested the resilience of so many, but in this time the staff has truly continued to shine and provide safe, quality care to all our patients. We want to thank the community for honoring them during some of the hardest times. Even through these new times, we continue to celebrate our staff with special lunches, events, and recognitions.

Message from Frank Dominguez, President and CEO:

At El Paso Health, the year 2020 challenged our entire management team and associates to be agile, to work with creativity, and to remain focused on providing services to our Members through social distancing and lockdowns. For the most part, the year could be described as one in which our personal, high-touch company had to find ways to work through plexiglass and masks.

Everyone at El Paso Health rose to the occasion for our Members, Providers, and Partners. For our Members, our goal was to not have any service interruptions while adapting to the COVID-19 restrictions. In that regard, our leadership and staff focused on ways to stay in touch with our Members, provide them with ease-of-access to us, and to work through protocols and restrictions that often changed daily. This took a great deal of flexibility and innovation as we adapted to a new normal. Again, I am so proud of our entire staff: we didn't miss a beat when it came to caring for our Members and making sure they were fully covered and receiving all benefits.

As we turned 20 years old in 2021, our business reflected significant growth, continuing a steady, seven-year trend of membership gains over our competitors. We now provide services to over 99,000 members throughout our region, across all business lines and including our

CHIP and STAR programs. Importantly, we began our first year of offering **El Paso Health Plus**, our Medicare Advantage Plan, to El Pasoans who need both Medicaid and Medicare programs and coverage. This program remains a strong and positive offering from El Paso Health, and we look forward to greater growth in 2021.

To meet the demands of 2020 and stay true to our mission of also building relationships with Providers and Partners, we introduced a number of new, innovative services. One of the most important new services introduced during the year was VeMiDoc. This mobile application is a patient/Provider telemedicine app and allows patient-doctor visits to happen securely and in real time, all from a computer, tablet, or phone. Simultaneously, we developed and launched our Virtual-Connect program that allows Case Managers and Members to meet virtually. This program gives the case manager a personal connection with the Member, allowing a better opportunity to assess the Member's actual physical and mental well-being.

In addition, we strengthened our partnership with PHIX, a health-information exchange platform that will help us improve health in the region through collaboration and data technology. PHIX "centralizes" health information from different hospitals and providers to create an electronic health record for each patient.

We also established a free food basket program, Food from the Heart, for new Members who participate in our New-Member orientation. In addition to the food baskets from our own Food from the Heart program, we also gave away 180,000+ pounds of food to El Pasoans in partnership with El Pasoans Fighting Hunger Food Bank. And we provided 494 infant and child car seats to our Members as part of our extra Member Benefits.

These partnership programs are our commitment to the Community, and we are proud that in addition to these initiatives, we made financial contributions during the year to a number of local non-profits in the amount of \$220,000, including to the University Medical Center and El Paso Children's Hospital Foundations.

We are El Paso's only local, non-profit health plan. And in the new year, we will continue our commitment to provide the best available services to our Members, our Providers, and our Partners.

Taylor Moreno, Program Director for El Paso Children's Hospital Foundation, is a fifth generation El Pasoan. Every generation has held positions that provided benefit to the community she calls home. Taylor's grandmother, Betty Thurmond, wife of William Thurmond, an attorney in El Paso, volunteered I,000 plus hours at UMC when it was still R.E. Thomason General Hospital and sat on the Board of Managers. She instilled in Taylor's mother, Elizabeth Thurmond Bengtson, how good this community has been to their family and how the family needs to return the favor and give back.

"My mom was always an active member of the Junior League and as a single mom, my brother and I went with her," said Taylor. "Growing up, we were never allowed to sleep in. We got up early and went out and volunteered with our mom." Today her mother is the director of institutional advancement at UTEP.

So it was little surprise when Pablo Magdaleno, Development Manager for New York Life Insurance Company and Board Member for UMC and El Paso Children's Hospital Foundations nominated Taylor for the Love Takes Action Award from the New York Life Foundation. As one of 35 community members from across the nation embodying "love takes action," Taylor has been awarded a \$50,000 grant for El Paso Children's Hospital.

"She selflessly gave back to the community during the pandemic," said Pablo. "She stepped up when her community needed her the most."

In addition to bringing in many grants specifically to help El Paso Children's Hospital during the pandemic, Taylor spent personal time and resources, too, cooking for at-risk individuals and food-insecure families.

Taylor has since passed this generous spirit on to her son, Camden, who is seven years old. When he had surgery at El Paso Children's Hospital in 2018 and Taylor asked him what might he like as a treat after the procedure, he said he'd like a Happy Meal. "But then he said," she remembers, "Shouldn't all the sick kids in the hospital get a Happy Meal, too?" That evening, Camden received permission from hospital staff to go door to door, handing out a Happy Meal to all the patients. "It made an impact on him," she recalls.

Taylor has hearty plans for El Paso Children's Hospital's future. "I want to continue to grow the hospital endowment and put it to the level of other children's hospital foundations throughout the nation," she said. Taylor has raised seven million dollars for the hospital in four years. "Every job that I've taken, I believe it has given back to the community in one way or another. I just want to continue to make an impact on the community in personal and professional ways."

ESTELA CASAS INFUSION CENTER FOR HOPE AND HEALING

In the midst of the pandemic of 2020, the Estela Casas Infusion Center for Hope and Healing sought comfort and convenience as top priority for its oncology patients who were encouraged to continue treatment. Besides, the open 15-bay facility with large windows to provide light, an on-site laboratory and radiology services eased the transition of treatments

for patients. The Marcy Aboud Infusion Boutique remained opened for patients to learn how to wear scarves, hats and how to apply cosmetics, all at no charge. However, in February 2020, the Patient Support Group that serves as an avenue to educate patients on various topics was forced to be placed on hold as was the Support Group Christmas Party with a visit from Santa Claus, an annual event for patients and their families. Power of Pink was also not held due to safety measures and social distancing. Power of Pink recognizes and supports breast cancer survivors throughout El Paso and distributes information and services about the Estela Casas Infusion Center for Hope and Healing to employees, patients, and visitors.

Good advancements continued to happen, though as the Estela Casas Infusion Center for Hope and Healing retained its goal to certify as many nurses as possible; and in

turn, for the nurses to continue to enhance their knowledge in nursing and their particular specialty. Three new certifications were given to Catherine Lopez in oncology; Brandon Rodriguez in medical/surgical nursing, and Cynthia Reizer, also in oncology. The Commission on Cancer revised its requirements for 2019, requiring all nurses administering chemotherapy and immunotherapy to be certified in oncology or have 12 hours of cancer-related continuing education. The Center received its Commission on Cancer Accreditation in August 2020 from the American College of Surgeons Commission on Cancer.
