

EL PASO COUNTY HOSPITAL DISTRICT NOTICE OF MEETING TO VOTE ON TAX RATE

PROPOSED TAX RATE \$0.219526 per \$100

NO-NEW-REVENUE TAX RATE \$0.219526 per \$100

VOTER-APPROVAL TAX RATE \$0.233385 per \$100

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for the El Paso County Hospital District from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval tax rate is the highest tax rate that the Commissioners Court of the County of El Paso, on behalf of the El Paso County Hospital District, may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that the Commissioners Court of the County of El Paso, on behalf of the El Paso County Hospital District, is not proposing to increase property taxes for the 2024 tax year.

A public meeting to vote on the proposed tax rate will be held on Monday, August 26, 2024 at 9:30 a.m. at the El Paso County Courthouse, third floor, Commissioners Court Chambers.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, the El Paso County Hospital District is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the El Paso County Commissioners Court, on behalf of the El Paso County Hospital District, at their offices or by attending the public meeting mentioned above.

Your taxes owed under any of the above rates can be calculated as follows:

Property tax amount = tax rate x taxable value of your property / 100

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by the El Paso County Hospital District last year to the taxes proposed to be imposed on the average residence homestead by El Paso County Hospital District this year.
